

CALL FOR SUPPORT TO SHORT-TERM COURSES

WITH INTERNATIONAL SCOPE – 2024/2025

Within the scope of the Teaching Excellence Program and the Fiocruz Institutional

Internationalization Program, the Vice-Presidency of Education, Information and Communication,

through the General Coordination of Education at the Oswaldo Cruz Foundation, aiming to support

international courses of Fiocruz's stricto sensu Postgraduate Programs with foreign institutions,

announces this call that will grant resources to support the implementation of international courses.

The application for this call needs to be submitted by a researcher/professor from a Fiocruz's

stricto sensu Postgraduate Program.

OBJECTIVES

• This call aims to attract renowned professors working and residing abroad to teach short-term

courses with an international scope within the framework of *stricto sensu* Postgraduate Programs

(see item 2), transforming the course workload into credits for students.

• Encourage the attraction of international leaders with outstanding scientific and technological

production to contribute to the innovation of Postgraduate Programs, and to enhance the

development of internationalization and excellence in education at Fiocruz.

• Contribute to the internationalization of *stricto sensu* Postgraduate studies, as well as to

advancements in science, technology and innovation.

REQUIREMENTS

The courses should be aimed at students enrolled in Fiocruz's *stricto sensu* Postgraduate

Programs and registered on the *Plataforma Sucupira*.

• The course proposal must be presented containing:

- A Proposing professor, who must be a current employee at Fiocruz, working as a

permanent professor in one of Fiocruz's stricto sensu PPGs registered on the Sucupira

Platform, have an international profile and be in line with Fiocruz's Internationalization

Policy. The proposing and organizing professor will be the coordinator responsible for

submitting the course proposal, in accordance with this call.

FIOCRUZ

• The visiting professor must be an international researcher who meets the following requirements:

equirements.

Be a foreign national or Brazilian working and residing abroad;

- Hold a doctoral degree for at least 1 (one) year, with recognized competence in their field

of activity and with relevant academic production in the period from 2019 to 2024.

In compliance with Fiocruz's Open Access to Knowledge Policy, the course organizer and visiting

professors will assume the following commitments when submitting the proposal:

-Deposit the course material and intellectual works produced for use in the course in the

Institutional Repository, for the purpose of making them available in Open Access, under

the terms and in accordance with the provisions of Fiocruz's Open Access to Knowledge

Policy;

-Copyright Assignment Agreement to be signed by the organizer and visiting professors

(Annex V);

-Non-exclusive assignment of the author's property rights for the course and any intellectual

works produced for use in the course, including publications, for all non-commercial

purposes. This includes, but is not limited to, public availability in Open Access, in

accordance with Fiocruz's Open Access to Knowledge Policy;

-The material made available in Open Access may include text, video, or audio formats, in

accordance with institutional standards and guidelines.

APPLICATION PROCESS

• To apply for selection, the visiting professor must send the following documents to the

proposing professor:

- Annex VII - Letter of Agreement, signed by the visiting professor, regarding the

proposed activities;

- An updated brief CV of the visiting professor, in free format, in Portuguese, English or

Spanish, covering the period from 2019 to 2024, with a maximum length of 5 (five)

pages.

Daily allowances will be paid via international remittance and there will be administrative fees for this service.

personal data, specifically <u>Law No. 13,709 of August 14, 2018 (LGPD)</u>, as well as in
accordance with other relevant legislation and the provisions outlined in this call.

The processing of photos, videos, images and/or audio recordings collected during courses/events may be conducted through specific Fiocruz or third-party platforms, with which data requested from teachers may be shared when carrying out the course or when reporting on the course/event, in compliance with the legal bases presented in this document for this operation.

1. - GRANTED RIGHTS
